Data communication	Personal data will not be disclosed and will be communicated, for the stated purposes, exclusively to subjects who carry out activities on behalf of the Data Controller, duly appointed as data processors. Upon explicit request, personal data may be disclosed to public authorities.
Non-EU data transfer	Although the Data Controller undertakes to choose services that reduce the processing of personal data of its users to a minimum, the processing of personal data for the aforementioned purposes which provides for the use of cookies and other tracking tools could involve the transfer of some data, only indirectly identifying the interested party, in countries that are located outside the territory of the EU or the European Economic Area (EEA), in particular towards the United States where the interested party may not enjoy similar rights and protections such as those guaranteed in the territory of the Union. The interested party, therefore, in giving consent to tracking by means of cookies, for statistical analysis and advertising purposes, also with profiling, consents to their data being potentially subject to processing even outside the EU/EEA. For the other purposes described above, personal data will not be transferred to countries outside the EU or the European Economic Area. If this is necessary, the transfer will take place only in the presence of adequate guarantees in compliance with current legislation.
